Applications are invited from Indian nationals for 9 (Nine) contractual positions of Scientists in the project titled "Establishment of Biosafety Support Unit (BSU)" on the following term and conditions :

- (i) The positions are purely on contract basis and will be governed by the terms and conditions prescribed by Regional Centre of Biotechnology, Gurgaon for contract positions.
- (ii) The Remuneration for the contractual positions will be Rs. 50,000/- to Rs. 70,000/- per month based on experience.
- (iii) The age limit 35 years on the last date of application.

- c. The RCB reserves the right to relax qualification, experience and age limit for otherwise exceptional candidates. RCB may also offer higher remuneration for experienced candidates.
